Mortgage rates rose slightly this week, moving from 6.35% to 6.38%. The PCE report came in largely as expected, while bond yields moved higher on the Fed's cautious outlook and lingering inflation concerns. Even with those pressures, the increase in mortgage rates was minimal, leaving the overall picture little changed from the week before.
